TOURNAMENT RULES

- Entry is open to all female members of the Mississippi State USBC who are 50 years of age or older at the time of participation in the state competition. USBC Sanctioned
- 2. Tournament will consist of a singles event. A total of six (6) games will be bowled. Three (3) games will be bowled on each day or ALL six (6) games may be bowled on Saturday or Sunday (providing lanes are available).
- Entrants may compete only one (1) time in the event. Bowler must be within the age
 division at the time she bowls. Appropriate attire is required during tournament play.
 Tournament Manager will make final decision.
- 4. Handicap will be 90% of 200
- 5. Bowler's entering average will be:



- a. Highest USBC average in one league as of the end of the previous winter season for at least 21 games
- b. If no average from last year, the highest current average in one league as of opening date of tournament for at least 12 games
- c. Bowlers with neither of these averages must bowl scratch
- d. USBC rules 319a-2, 319d and 319e do not apply: but 319a-3 does apply
- 6. Closing date for entries will be **October 16, 2024**. Substitutes after this date will be allowed only with a written letter of release from the original entrant and an average verification from the local Association Manager. If the substitute has no letter of release, she must pay the entry fee for that position.
- 7. Should any entry fail to appear on time to bowl, entry fee will be forfeited
- 8. All prize money will be returned 100% in a ratio of at least one (1) prize for each five (5) entries

- Non-members can qualify for entry by purchasing an Associate Membership card for \$26.00
 (USBC rule 300c-1)
- 10. EACH DIVISION WINNER (HANDICAP) WILL RECEIVE A PAID ENTRY TO THE 2025
 USBC NATIONAL SENIOR TOURNAMENT
- 11. In case of a tie for the championship, the overall champion will be the bowler having the highest three (3) game series with handicap. If a tie still exists, then a decision will be made based on the following order:
 - a. The bowler having the highest series with handicap on Saturday
 - b. The bowler having the highest game with handicap on Sunday
 - c. The bowler having the highest series with handicap on Saturday
 - d. The bowler having the highest game with handicap on Sunday
- 12. All cell phones MUST be turned on silent during tournament play
- 13. The Tournament Manager shall decide any question not covered by USBC Rule 329
